OTP Bank Plc. announces that in order to cover the ETFBUXOTP fund on 9 September 2009 the Bank purchased 180 own shares at an average price of HUF 4,873 per share, with the contribution of OTP Bank as investment service provider.

Accordingly, the total number of treasury shares of the Bank changed to 2,186,391 common shares. The number of treasury shares at Group members was 2,098,560 on 30 August 2009. All in all, the treasury shares account for 1.53 percent of the Bank's registered capital.
