OTP Bank Plc. announces that in order to cover the ETFBUXOTP fund on 6 October 2009 the Bank sold 440 own shares at an average price of HUF 5,191 per share, with the contribution of OTP Bank as investment service provider.

Accordingly, the total number of treasury shares of the Bank changed to 2,185,765 common shares. The number of treasury shares at Group members was 2,098,560 on 29 September 2009. All in all, the treasury shares account for 1.53 percent of the Bank's registered capital.
