OTP Bank Plc. announces that in order to cover the ETFBUXOTP fund on 22 January 2010 the Bank purchased 115 own shares at an average price of HUF 5,777 per share, with the contribution of OTP Bank as investment service provider.

Accordingly, the total number of treasury shares of the Bank changed to 2,186,195 common shares. The number of treasury shares at Group members was 2,098,560 on 30 December 2009. All in all, the treasury shares account for 1.53 percent of the Bank's registered capital.
