OTP Bank Plc. announces that in order to cover the ETFBUXOTP fund on 17 February 2010 the Bank sold 45 own shares at an average price of HUF 5,610 per share, with the contribution of OTP Bank as investment service provider.

Accordingly, the total number of treasury shares of the Bank changed to 2,187,086 common shares. The number of treasury shares at Group members was 2,098,560 on 31 January 2010. All in all, the treasury shares account for 1.53 percent of the Bank's registered capital.
