Treasury share transaction

OTP Bank Plc. announces that within the framework of the Remuneration policy of OTP Bank Plc. and OTP Group board members' share-based remuneration in particular, on 9 May 2016 the Bank sold 92,586 own shares in line with guidelines set out in the Remuneration policy of OTP Bank Plc.

Consequently, the total number of treasury shares at OTP Group changed to 3,574,940 common shares. (Within that, the number of treasury shares at OTP Group members outside the mother company was at 2,073,560 as of 30 April 2016). All in all, the treasury shares account for 1.28 percent of the Bank's registered capital.
