

Extraordinary announcement

Treasury share transaction

OTP Bank Plc. announces that – according to the Resolution No. 10/2025 of the Annual General Meeting on 25 April 2025, as a part of implementing the Bank's remuneration policy – on 6 May 2025 the Bank purchased 123,328 own shares at an average price of HUF 26,151 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 10,048,920 shares. The stock of own shares is 3.59%.
